(1) Share option(s) comprising 300,000 shares was / were cancelled during September 2016 at the exercise price HK\$1.462 per share under the Share Option Scheme. The number of new shares of the Company which may be issued pursuant thereto as at close of the month at the exercise price of HK\$1.462 per share under the Share Option Scheme should be 47,350,000 instead of 49,650,000.

(2) Ms. Su Shiqin resigned as an executive director and the chief financial officer of the Company and its subsidiaries with effect from 10 September 2015. She did not exercise the share options within 12 months following her resignation under the Share Option Scheme and the share options lapsed on 9 September 2016.

(3) Share option(s) comprising 500,000 shares was / were cancelled during September 2016 at the exercise price HK\$0.59 per share under the Share Option Scheme. The number of new shares of the Company which may be issued pursuant thereto as at close of the month at the exercise price of HK\$0.59 per share under the Share Option Scheme should be 98,700,000 instead of 99,200,000.
